# **Monthly Council Meeting Minutes**

June 19, 2017

Mayor Armstrong called the meeting to order at 19:00 PM.

Moment of Silence was allowed and followed by the Pledge of Allegiance.

### **COMMITTEE REPORTS:**

Health & Sanitation - Upcoming water project schedule to be worked out by John pending date of delivery of hydroexcavator vehicle.

Will place \$200,000 down and finance the remaining \$200,000 @ \$35,000/yr. Motion made by Peggy/2<sup>nd</sup> by Eddie; passed unanimous.

Garbage truck – will make offer of \$125,000 cash. Motion made by Peggy/2<sup>nd</sup> by Eddie; passed unanimous.

Recreation – Bingo cont's to do well on 3<sup>rd</sup> Thursdays in the Gym until fire code matters are resolved. Must re-bid contract as previous bidder backed out.

Streets & Lights - 2 lights at 211 & corner of 2<sup>nd</sup> St. & 5<sup>th</sup> Ave. comes on during the day and goes out at dark.

Building – 2 permits presented to Jay.

## Finance - Larry reported the following balances:
