

CHAPTER ONE  
GENERAL PROVISIONS

1.1.1 General Objective of Code – This Code of the general laws of The Town of Glasgow, West Virginia, is intended, so far as feasible, to encompass all the general ordinances of the Town. It does not encompass orders, resolutions, or special ordinances of the Town relating to specific projects or specific items of business of the Town.

1.1.2 Amendment, Repeal, Supplementation – This Code, and the respective ordinances herein contained, may, from time to time, as the Council may by appropriate action determine, be amended, repealed in whole or in part, or supplemented. So far as feasible, any ordinance amending, repealing, or supplementing the whole or any part of this Code or of any ordinance contained herein shall be numbered in such manner as to conform generally to the scheme of numbering herein employed, but failure of such amending, repealing, or supplementing ordinance so to conform in numbering shall not invalidate the same in any respect.

1.1.3 Numbering; Headings – The scheme of numbering in this Code and the headings appearing on Chapters, Articles, and Sections are for convenience only and constitute no part of the substance of such Chapters, Articles, and Sections.

1.1.4 Definitions – As used throughout this Code and in any ordinance amending, repealing in whole or in part, or supplementing this Code or any ordinance herein contained, the following terms shall, unless a different meaning is, in any Chapter,

Article, or Section, specifically indicated, have, and be interpreted as possessing, the following meanings:

1.1.4.1 "The Town" shall mean The Town of Glasgow, West Virginia, a municipal corporation.

1.1.4.2 "Council" shall mean the Common Council of the Town, constituted as prescribed in Section 2.1 of Chapter 2 of this Code.

1.1.4.3 "Person" shall mean a person, firm, or corporation.

1.1.4.4 "Code" shall mean the codification of the general ordinances of the Town which initially consist of chapters numbers 1 through 23, which are contained in this ordinance book, and which, by action duly taken by the Council, became effective on the 1<sup>st</sup> day of July, 1982, as it exists on such effective date and as it shall hereafter, from time to time, be amended, repealed in whole or in part, or supplemented by ordinance subsequently adopted by the Council.

1.1.5 Repeal of Conflicting Ordinances – Effective on the date specified in subsection 1.1.4.4. of this Chapter, any order, resolution, or ordinance of the Town which is inconsistent or in conflict with any provisions of this Code is hereby repealed. Notwithstanding the generality of the provisions of the next preceding sentence, and without impairing its validity and effectiveness, there are hereby specifically repealed, effective on the dates specified in subparagraph 1.1.4.4 of this Chapter, the following ordinances of the Town, all of which are now contained in an ordinance book of the Town labeled "Repealed Ordinances", to-wit: Chapter One, Municipal Officers; Chapter Two, Police Court Procedures; Chapter Three, Licenses; Chapter Four, Collection of Taxes; Chapter Five, Resisting Officers; Chapter Six, Gambling; Chapter

Seven, Obstructing Streets; Chapter Eight, Disorderly Conduct; Chapter Eight, Streets; Chapter Nine, Offenses Against Morality and Decency; Chapter Ten, House of Ill Fame; Chapter Eleven, Government and Regulation of the Council; Chapter Twelve, Offenses Against Property; Chapter Thirteen, An Ordinance to Prevent the Obstruction of Streets, Walks, Ditches and Drains to Promote Sanitation; Chapter Fourteen, Offenses Against Public Policy; Chapter Fifteen, Public Health; Chapter Sixteen, An Ordinance to Prevent Livestock from Running at Large; Chapter Seventeen, An Ordinance to Regulate Building; Chapter Eighteen, Salaries of Town Officials; Chapter Nineteen, Transaction of Business of Town Officials; Chapter Twenty, Cattle Running at Large; Driving Vehicles While Intoxicated, Chapter Twenty-One, Fixing 10:00 as Curfew Time; Maintenance of Hogs; Chapter Twenty-Two, Dog; Chapter Twenty-Three; Traffic; Collision with Parked Vehicles; Reckless Driving; Chapter Twenty-Four, Riding Bicycle on Sidewalks; Chapter Twenty-Five, Traffic; Driving Across Fire Hose; Safety Zones; Chapter Twenty-Six, Salaries of Town Officials, Chapter Twenty-Seven, Qualifications of Officers; Chapter Twenty-Eight, Emergency Blackouts; Chapter Twenty-Nine, Amendments to Chapters Eleven, Twelve, and Thirteen; Chapter Thirty, Elections; Chapter Thirty-One, Fireworks; Chapter Thirty-Two, Sewer Connections, Chapter Thirty-Three, Tax on Beer; Chapter Thirty-Four, Parking Vehicles; Chapter Thirty-Four-A, Parking Vehicles—Amendatory Ordinance; Chapter Thirty-Five, Surface Drainage; Chapter Thirty-Six, Refuse—Collection; Scattering; Chapter Thirty-Seven, House Trailers; Chapter Thirty-Eight, Offenses Generally; Chapter Thirty-Nine, Impeding Streets by Trees, Shrubs, etc.; Chapter Forty,

**Nuisances; Chapter Forty-One , Building Unfit for Human Habitation; Chapter Forty-Two, Board of Park Commissioners.**

**Some of the ordinances hereinabove in this Section specifically identified by title and specifically repealed have, in whole or in part or in modified form, been reenacted in this Code. Such ordinances, as so reenacted and as so contained in this Code, shall, in no way and to no extend, be affected by the repealing provision contained in this Section, it being the intention of the Council that such repealing provision shall be effective only with respect to such repealed ordinances as, and in the form in which, they existed prior to the effective date specified in Section 1.1.4 aforesaid.**
