

AN ORDINANCE OF THE TOWN OF GLASGOW, WEST VIRGINIA, ADOPTED PURSUANT TO THE PROVISIONS OF SECTION 4, ARTICLE 11, CHAPTER 8 OF THE CODE OF WEST VIRGINIA OF 1931, AS AMENDED, ADOPTING A COMPREHENSIVE CODE OF GENERAL ORDINANCES OF THE TOWN OF GLASGOW, WEST VIRGINIA, ENTITLED "CODE OF GENERAL ORDINANCES OF THE TOWN OF GLASGOW, WEST VIRGINIA," RELATING TO GENERAL PROVISIONS; ELECTIONS; CRIMES AGAINST THE PERSON; CRIMES AGAINST PROPERTY; FIREARMS AND OTHER WEAPONS; STREETS, PUBLIC WAYS, ABUTTING PREMISES; PUBLIC PEACE AND SECURITY; MISCELLANEOUS OFFENSES; MOTOR AND OTHER VEHICLES; PARKING OF VEHICLES; ALCOHOLIC BEVERAGES AND CONTROLLED SUBSTANCES; PUBLIC SOLICITATIONS; OFFENSES RELATING TO DOGS; MEMBERSHIP IN UPPER KANAWHA VALLEY DOG CONTROL BOARD; NUISANCES; SURFACE DRAINAGE; COLLECTION AND REMOVAL OF REFUSE; BUILDINGS UNFIT FOR HUMAN HABITATION; HOUSE TRAILERS; BUILDING PERMITS; OFFENSES BY RAILROADS; PUBLIC SERVICES IN THE TOWN UTILIZING WIRES OR CABLES; AND PENALTIES FOR VIOLATION; PROVIDING FOR THE FILING OF COPIES WITH THE RECORDER; PROVIDING FOR PUBLICATION OF NOTICE OF THE ADOPTION OF SUCH CODE; SPECIFYING AN EFFECTIVE DATE FOR SUCH CODE; AND PROVIDING FOR THE REPEAL OF INCONSISTENT ORDINANCES.

BE IT ORDAINED by the Council of The Town of Glasgow, West Virginia, as follows:

1. Adopting Provision - - Pursuant to the provisions of Section 4, Article 11, Chapter 8, of the Code of West Virginia of 1931, as amended, there is hereby adopted a comprehensive code of the general and permanent ordinances of The Town of Glasgow, West Virginia, entitled "Code of General Ordinances of The Town of Glasgow, West Virginia," the same to be hereinafter referred to as "the Code," consisting of ordinances of a general and permanent nature and containing, in its form as initially adopted hereby, chapters numbered One through Twenty Three.

2. Filing with Recorder - Copies of the Code, in numbers sufficient for public inspection and use are, on the date of the introduction of this ordinance, on file in the office of the Recorder of the Town, and shall, at all times, be so kept on file

pending the adoption of the Code and thereafter so long as the Code, in its initial or amended form, shall be in effect, and shall, during regular business hours be available for inspection and use by the public.

3. Publication of Notice – Notice of the proposed adoption of this ordinance and of the Code shall be given by publication in accordance with the provisions of Section 4, Article 11, Chapter 8 of the Code of West Virginia of 1931, as amended.

4. Effective Date – The provisions of the Code shall become effective on the 1<sup>st</sup> day of July in the year 1982, and, subject to the amendment, supplementation, or repeal thereof, in whole or in part, shall thereafter continue and remain in full force and effect.

5. Repeal of Other Ordinances – Effective on the 1<sup>st</sup> day of July in the year 1982, all general ordinances of the Town which are inconsistent with the provisions of the Code or of any ordinance therein contained are hereby repealed, and there are specifically hereby repealed all ordinances specifically described by title in 1.1.5 of the Code, which said specifically described ordinances are contained in an ordinance book of the Town captioned “Repealed Ordinances.”
